Subject: 2020 Local Partnership Formulaic Program Adoption – Program of Projects,

Resolution G-20-78

Recommendation:

Staff recommends the California Transportation Commission (Commission) adopt the 2020 Local Partnership Formulaic Program of projects as identified in Attachment B.

<u>lssue:</u>

On March 25, 2020 the Commission adopted the 2020 Local Partnership Formulaic Funding Distribution for Fiscal Years 2020-21 through 2022-23 totaling \$324,000,000 for 44 eligible taxing authorities. Only the agencies listed in the adopted fund distribution are eligible to receive formulaic funding. The adopted 2020 Local Partnership Program Guidelines state that the Commission will consider adopting project nominations on a case-by-case basis in advance of the program adoption scheduled for December 2020.

Fourteen agencies submitted 25 project proposals by the June 12, 2020 deadline. Subsequently, six additional agencies submitted five project proposals for a total request of 30 projects from 20 eligible agencies. The 30 project proposals requested a total \$202,859,000 in formulaic funds. Commission staff reviewed the project proposals for eligibility and consistency with the approved guidelines. Through the review process, staff ensured applicant agencies had an opportunity to verify, review, and request modifications prior to releasing staff recommendations. Eight agencies requested advance programming for nine projects totaling \$45,207,000. The Commission approved the nine projects at the June, August and October 2020 meetings.

Staff prepared a recommended project list and posted it on the Commission's website on November 16, 2020. The project list includes 19 new projects and nine projects that were previously approved for funding. Two projects are not being recommended at this time because the agencies have asked to wait until a later date to program the projects.

In total, the 2020 Local Partnership Formulaic Program of Projects will program a total of 28 projects, totaling \$182,099,000 in Local Partnership Program funds.

Twenty-four agencies elected not to apply for their formulaic funds at this time. The 2020 Local Partnership Program Guidelines allow agencies with adopted 2020 formulaic funds to nominate projects for the 2020 Local Partnership Program until April 2023.

The 2020 Local Partnership Program Formulaic Program of Projects includes vital, diverse transportation projects throughout the state, as listed in Attachment B. The following are examples of projects proposed for funding:

Sacramento Transportation Authority

• City of Sacramento, Sacramento County – Corridor Improvements on Florin Road Project. The project will improve pavement conditions on a one-mile section of Florin Road from 24th Street to Munson Way, install safety improvements, buffered bike lanes, ten additional marked crossings, traffic signal improvements, and add landscaping and trees. This project will benefit residents of a vulnerable community, provide safety benefits, and improve the corridor to a state of good repair, especially for bicyclists and pedestrians. The Transportation Authority proposes \$2,248,000 in Local Partnership Formulaic Program funds for the Construction phase in Fiscal Year 2021-22.

City of El Cerrito

 City of El Cerrito, Contra Costa County - Richmond Street Curb, Signing, Marking Improvements Project. The project will improve a 1.7-mile-long arterial street, specifically, rehabilitate and maintain street pavement; install new and modified curb ramps and tactile domes; install traffic signing, pavement markings and signs to enhance crosswalks; replace vehicle signal loop detection enhancing bike detection; and make minor utility adjustments to grade. The City proposes \$400,000 in Local Partnership Formulaic Program funds for the Construction phase in Fiscal Year 2022-23.

Fresno County Transportation Authority

Fresno County - Veterans Boulevard Interchange and Extension – Phase 4b Project.
 This project is part of a multi-phase interchange and roadway extension project. This phase will connect Veterans Boulevard to Herndon Avenue in the north and Shaw Avenue in the south and install a pedestrian trail and adaptive intelligent transportation system technology to synchronize traffic operations in real-time. The project will result in safety benefits and travel time savings. The Transportation Authority proposes \$1,904,000 in Local Partnership Formulaic Program funds for the Construction phase in Fiscal Year 2020-21.

Los Angeles County Metropolitan Transportation Authority

• Los Angeles County - Metro Red and Purple Line Core Capacity Improvements Project. This project is part of a larger project that will accommodate increased service levels on the Metro Red and Purple Lines. To achieve combined two-minute headways on the Metro Red and Purple Lines, the Division 20 Yard Portal will be widened, and the tracks will be modified to allow cross-over and improved access to the current Division 20 Yard. The Division 20 Yard will contain a new turnback facility that will double the number of trains per hour that can travel in each direction through the section of the Metro Rail system that serves both the Metro Red and Purple Lines. This project will reduce wait times, reduce crowding and improve the reliability of the heavy rail system. The agency proposes \$112,518,000 in Local Partnership Formulaic Program supplemental funds for the Construction phase.

After approval of this item, the remaining Local Partnership Formulaic funds available for programming is \$177,940,000 as listed below:

Background:

Senate Bill (SB) 1 (Chapter 5, Statutes of 2017) created the Local Partnership Program, and Assembly Bill 115 (Chapter 20, Statutes of 2017) clarified SB 1 language regarding local and regional transportation agency eligibility and expanded the types of projects eligible for the program. The program provides funding to counties, cities, districts, and regional transportation agencies in which voters have approved fees or taxes dedicated solely to transportation improvements.

SB 1 authorizes \$200 million annually to fund the Local Partnership Program appropriated from the Road Maintenance and Rehabilitation Account. These funds are split between the Competitive Program and the Formulaic Program. The 2020 Local Partnership Formulaic Program portion of funds are \$108 million annually for Fiscal Years 2020-21 through 2022-23.

- 1.1 **WHEREAS**, on April 28, 2017, Governor Brown signed Senate Bill 1 (Beall, Chapter 5, Statutes of 2017), enacted as the Road Repair and Accountability Act of 2017, creating the Local Partnership Program; and
- 1.2 **WHEREAS**, on June 27, 2017, Governor Brown signed Assembly Bill 115 (Ting, Chapter 20, Statutes 2017) which clarified language in Senate Bill 1 regarding local and regional transportation agency eligibility and expanded the types of projects eligible for the program; and
- 1.3 **WHEREAS**, the Local Partnership Formulaic Program provides funding to counties, cities, districts, and regional transportation agencies that have sought and received voter approval of taxes or fees dedicated solely to transportation improvements; and
- 1.4 **WHEREAS**, Senate Bill 1 authorizes \$200 million annually to fund the Local Partnership Program appropriated from the Road Maintenance and Rehabilitation Account, and these funds are split between the Competitive Program and the Formulaic Program. The 2020 Local Partnership Formulaic Program portion of funds are \$108 million annually for Fiscal Years 2020-21 through 2022-23; and
- 1.5 **WHEREAS**, only agencies with Commission-adopted formulaic funding and committed local matching funds are eligible to request formulaic funding for proposed projects; and
- 1.6 **WHEREAS**, on March 25, 2020, the Commission adopted the 2020 Local Partnership Formulaic Funding Distribution for Fiscal Years 2020-21 through 2022-23, totaling \$324,000,000 for 44 agencies; and
- 1.7 **WHEREAS,** eligible agencies submitted project proposals and staff reviewed project proposals for compliance with Local Partnership Program Guidelines; and
- 1.8 **WHEREAS**, staff prepared a recommended project list and posted it on the Commission's website on November 16, 2020; and
